The Multidisciplinary Team (MDT)/ Criminal Justice (CJ) Program Serves 2 Distinct Populations:

Birth to 5 years 11 months young children at risk for developmental delay:

- Infants, toddlers and young children ages birth to 5 years 11 months who are victims of violent crime, physical abuse or neglect, sexual abuse, domestic violence, or have been taken or kidnapped in a high conflict custody or trafficking situation; are at higher risk for experiencing developmental delays and stressful parent/caregiver child relationships.

IDD Individuals with Developmental Disabilities ages 6 years through adult:

- Individuals with disabilities are victims of violent crime at exponentially higher rates than individuals without disabilities.

- Although disproportionately affected, Tarrant County residents with disabilities are without services specifically designed to respond to their unique needs as victims of crime. Couple this with the low rate of statistics on cases that are actually prosecuted when people with IDD are bullied, abused or neglected.
- A local unit of government, MHMR of Tarrant County (MHMR) will respond to this need through the MDT/CJ Program.

The MDT/CJ Team Members include;

- **Licensed Clinician's** providing evidenced based trauma therapy interventions and assessments.
- **Licensed Trauma Therapists** providing Trust Based Relational Interventions with families for children with developmental delays. Providing joint planning, coaching, and consultation to families with children ages 3 to 6 who experience developmental delays.
- **Occupational Therapists** providing consultation to providers on individualized therapeutic activities, evaluations, and assessments to meet sensory and routines-based needs.
- **Behavior Supports Specialist** consultations, behavior support consultation services help with supporting individuals in understanding the function of behavior through assessments and observations and may involve designing Positive Behavior Support Plans, which include teaching parents and caregivers' behavioral interventions and strategies that lead to positive replacement behaviors.

Who is eligible for the MDT/CJ Program?

Children birth to 5-years, 11 months and individuals ages 6 years through adults with Intellectual & developmental disabilities living in Tarrant County who have experienced:

- sexual abuse
- physical abuse
- neglect
- experienced or witnessed domestic violence
- experienced being kidnapped or taken (custody or trafficking)

What is the Goal of the MDT/CJ Program?

- To reduce the impact of Trauma on the parent-child relationship
- To reduce the risk for developmental delays in children
- To promote a healthy parent-child attachment
- To enhance and/or build the capacity of the parent/caregiver
- Increased ability for children to self regulate

What services are provided?

- Developmental Screenings
- Routine Based Interview/Assessment
- Child & Family Needs Assessment
- TBRI in home intervention
- Eye Movement Desensitization & Reprocessing (EMDR)
- Parent/Caregivers Support & Education
- Parent Café opportunities
- Behavior Support
- Occupational Therapy consultation

- Improved parent-child relationships
- Healthier attachments
- Decreased stress
- Having developmentally appropriate expectations
- Increased family protective factors
